Code of Conduct

This document outlines the required behavior associated with use of The Studio. Guests who violate these terms may be asked to leave. Repeated violations can result in the loss of student privileges.

Instructors are required to conduct themselves in an exemplary manner. This includes:

- Prompt arrival for all appointments
- Respect privacy of students and clients
- Encourage and guide the musical potential of all students
- Treat all present within The Studio with dignity and respect
- Respect the student's right to choose their place of instruction

All studio guests are expected to arrive promptly at or before their appointed time and remain present for the duration. Please make prior arrangements with the instructor if you know that there is a temporary or permanent change in your availability.

Parents to children under the age of 6 years old must be present for the duration of the lesson unless otherwise specified by the instructor.

All parents of minor children are welcome to observe lessons at any time. All other guests are subject to instructor approval.

All persons present in The Studio are required to conduct themselves professionally. This behavior includes:

- No offensive language, including recorded lyrics
- No rough play within the studio
- No smoking in or around the studio
- Appropriate clothing must be worn at all times

Studio time is to be used primarily for instruction, and excessive socializing or other disruptive behavior will not be permitted.

Contracted music students are expected to maintain the appropriate materials including books and equipment in their own homes, and are requested to practice at least 5 times weekly or as specified by the instructor. Please bring all of the required materials to your instructional appointment whenever possible to avoid unnecessary delays to your music education.

Covid-19 Policies

On January 3, 2022, our studio will open our doors for the Spring 2022 semester, offering in-person lessons in the downstairs group classroom at our studio. The set up will include 2 instructor digital pianos, a theory station, and 2 digital pianos in our piano lab. Our studio intends to follow the guidance offered by the CDC and the state of California to the best of our ability.

Concern 1: Ventilation

- Air conditioning and heating units vent directly out of doors
- A HEPA air purifier will also be in use

Concern 2: Sanitation

- Touch surfaces sanitized between uses
- Cleaning solution approved by CDC to kill Covid-19
- Hand Sanitation Station available for students

Concern 3: Masks

- Every person in the studio is required to wear a mask covering nose and mouth while indoors

Concern 4: Illness

Students will be asked to forego in-person lessons if they have any of the following symptoms:

- Fever above 101 F
- Thrown up or experienced diarrhea within 24 hours
- Actively coughing or sneezing uncontrollably
- Active eye or throat infection

Please self-report any symptoms, or known covid 19 exposure for the student or any household member. Make-up Lessons are available, and video recordings are available for group classes.

Concern 5: Supplies & Equipment

- Individual student binders and books
- Touchless Prize Wall

Concern 6: Performances

- LIVE online performances using Zoom
- Digital playlist of prerecorded student performances
- Student Showcase private viewing with one family group at a time
